Defendant Roblox Corporation provides this notice pursuant to the Class Action Fairness Act of 2005 and 28 U.S.C.A. § 1715. The parties to the above-referenced class action have reached a proposed settlement regarding individuals in the United States that have a Roblox account from which content on the Roblox platform was removed by Roblox. These individuals are alleging that, after such content was purchased using virtual currency, Roblox disabled, or "moderated," the content without adequately providing a credit or refund. Roblox maintains that this practice was expressly disclosed and agreed to in its Terms of Use but has nonetheless decided to change this practice and settle the litigation.
